There was discussion whether we should schedule a Board meeting over the summer to deal with developing issues such as SCO access and priority setting and it was agreed not to set a date at this time but to try to use email or hold a quick special Zoom meeting, if necessary. It was agreed that the next formal Board meeting would be scheduled for September

Judy Black has booked the fall Members' meeting dates September to December on the National Zoom account as webinars and the 6 Nova East talks will be hosted on the Centre Zoom account as meetings. The status of the September BBQ remains undetermined.

#### c) Guest Speakers and Ideas for Future Presentations

Nicole Mortillaro is scheduled guest speaker in September. Glenn Roberts is still a possibility as are Luigi Gallo and graduate students.

#### d) OH Presentations

#### 3. Report from National Council Representative

Pat Kelly indicated that there was nothing to report as there had been no meeting

#### 4. Outreach / Inreach

No activities had been reported. Zoom will continue to be used for virtual observing and special astroimaging sessions.

#### 5. RASC-Halifax Centre Website

Judy Black reported that policy G9 had been posted in the Policy section of the website and the new SCO use Guidelines had been posted in the Home page News and the SCO sections. The 2015 GA videos are also cited on the Home page News. An announcement for the Nova East COVID-19 Edition talks will be added to the Nova East site.

#### 6. Financial Update

Gregg Dill had circulated a June financial report by email in the afternoon before the meeting. He indicated that the longer we are shut down, the better we are financially. There was some discussion of where we stood overall, what was the current bank balance and the status of investments, which Gregg provided. In response to a question, Gregg reviewed the annual financial statement balances from 2015 to 2019, and he noted that the balance went into an annual deficit in 2017 and was in deficit in 2018 and 2019. There was some discussion about what had changed to cause this, but no conclusion was reached.

After our previous discussion about the Centre surcharge, Judy had asked other Centres about their surcharge and about how Star Party profits are dealt with. She had also asked National office for a breakdown of surcharges by Centre. The responses she received from other Centres and the list from National are presented in Agenda Note #2. It was noted that our surcharge is among the lowest and has not changed since it was established. There was some discussion, but no conclusion was reached. It was suggested that, due to COVID-19, this was perhaps not a good time to change the Centre's surcharge. This will be re-examined in May 2021.

#### **UPDATES / REPORTS**

#### 7. SCO Status

Judy Black reported that when she posted the new SCO Access document on the website, she had noticed that some of the links were out-of-date or were static.

#### 200618MN-Act03

Judy Black to review the SCO section of the website, correct out-of-date material and change static links to dynamic links.

John Liddard reported that he, Paul Gray, Blair McDonald and Dave Lane had had a productive meeting to review SCO

requirements and they had concluded that the upgrade would be relatively simple. Existing outlets should be electrified. They felt that a 200amp service would be more than enough power now and into the future. They suggested adding an external light to facilitate packing up, when required. They recommended four outlets in the warm room, four in the roll-off, and two outside. It was noted that better lighting in the warm room, both red and white, and dimmable, would be desirable. It was concluded that John should proceed with getting quotes regarding installation of the electrical panels.

#### 8. Report: Nova East Planning Committee Meeting

The report of the Nova East Star Party Planning Committee meeting #4 was included as Agenda Note #3. Judy Black indicated that speakers had agreed to Tuesday nights since National has Thursday evenings booked for events. The dates will be August 4 to September 8. Prices for t-shirt printing on-demand were not obtained so those wishing a t-shirt will be provided with the logo and they can go where they wish to have the logo applied to a t-shirt of their choice. The Astroimaging contest submission dates have been changed to August 21, 2020 to midnight September 11. A decision on prizes has been postponed for now. The web pages need to be updated.

#### 9. Update: The Discovery Centre

Wayne Harasimovitch and Peter Hurley reported that they had been in touch with Japna Sidhu-Brar at the Discovery Centre about following up on new collaborations. The Discovery Centre is planning to re-open to the public in mid-July and they are very busy preparing for that. It was agreed that they would plan to discuss next steps in mid-August and prepare a proposal for the September Board meeting, possibly for the Mars opposition in October.

#### 13. Evaluation of Zoom Account

An evaluation of the Halifax Centre Zoom account was included as Agenda Note #5. It was observed that there was more participation at the Members' meeting on Zoom than at the regular face-to-face meetings. A benefit of the special sessions on Zoom was that they were recorded, and members could go back and review them after they were posted. Other benefits for the Board were that the Board and Members' meetings were on separate dates, and News from the Board was a better presentation at the Members' meetings. It was agreed that we would keep the Zoom account and continue to use it. The cost will be applied against office administration budget.

### 14. Policy G10: Policies regarding permitted commercial activities at Halifax Centre Meetings and Events

Judy Black had provided a revision of the old policy, included as Agenda Note #6. The major change is that the responsibility for dispute resolution would now reside with the Board not the President. There were a couple of spelling and grammatical changes, and it was agreed to leave the form at the end as part of the document.

Dave should take the lead on the nominations for Quinn and with help from Mary Lou on the nomination for Blair.

Phil had suggested that we might be able to get a free Survey Monkey account, but that we could use their account if we notified him and Jenna Hines when we did.

There was discussion regarding whether to break the 32-questionaire into 2 parts; the consensus was to not break it up, to send it as one questionnaire. And there was consensus that it should go out in late June or July, as it's not a busy time, and to ask for a 2-week response time with a 1-week reminder.

## Agenda Note #3 re Item 9: 2015 GA video editing

## **REPORT ON RASC 2015 GA VIDEO EDITING PROJECT**

All the GA talks were recorded at the time (video of speaker, microphone audio, and slides) but only one was edited and published (Rob Thacker's Ruth Northcott Lecture.

It takes a couple of hours per talk (more for the longer ones) to put the files together, synchronize them, decide when to display the slide instead of the speaker, create a title and end credits, create a thumbnail, upload to YouTube, and possibly to re-edit after review.

It became apparent that the massive job of finalizing all the talks was not going to get done unless we paid to have it done. I knew Halley could do a professional job, so I made a proposal to RASC Halifax Council to hire her to do it. I felt that there was good material there and we should archive it properly. Also, it was important to transfer the files from the computer they were stored on and put them on an RASC-owned hard drive. Halley did not charge to do that.

RASC Halifax Council decided to apply to the RASC Special Projects Fund for support and received \$500 (the maximum), but we had to wait until May to get it.

That amount of money required us to prioritize—not all of the talks would see the light of day. In the meantime, the Mi'kmaw Moons Project paid Halley to edit the GA Banquet talk by Cathy LeBlanc and Dave Chapman.

Before the current project, these two videos were produced:

- 1. Galactic Archaeology: Raiders of the Lost Galaxy—Prof. Rob Thacker
- 2. One Moon—Two Eyes (Mi'kmaw Moons)—Cathy LeBlanc and Dave Chapman

Since Halley started the RASC-funded work, we have completed three videos:

- 3. The Ocean Tides of 2015—Prof. Roy L. Bishop
- 4. Astronomy Without Borders—Andrea Misner

5. Painting the Vault of Heaven: the St. John's Lunenburg Celestial Ceiling—Prof. Dave Turner and Randall Rosenfeld

## RASC Halifax Centre

## **Report – 2020 Zoom Account Summary**

#### Background:

Because a State of Emergency was declared on March 22, 2020, all face-to-face Board and Members' meetings and special events were cancelled. The national RASC opened its accounts for Centres to use to book meetings and special presentations shortly after the State of Emergency was announced.

Our meeting location at Saint Mary's University (SMU) was closed and the Friday, June 5th announcement stated all courses in the fall were to be offered virtually/online. In the COVID-related updates from the University on their website, it states: "At this time, the university is not permitting students, faculty, staff, and visitors on campus." Therefore, chances of us obtaining meeting space come fall is greatly reduced.

A Halifax Centre zoom meeting account was purchased and is to be evaluated at the June 18/20 meeting.

#### Cost of Zoom:

The Zoom Pro account was opened for meetings only on April 17, 2020 with the capacity to hold up to 100 participants at the cost of 20.00 + HST/month/host. Subscribing to a Zoom account annually with 30% off (140 + HST) works out to a 42% annual cost reduction. The 30% off option equates to five months free (refer to Table 1). How long the 30% reduction is available is the question!

Note: To host our own Video Webinar account would start at an additional \$53.00/month/host for 100 participants.

Patrick Kelly (as of May 22/20) was given the login information to set up and potentially host meetings on the Centre's behalf.

#### Zoom Usage:

Tables 2 and 3 provide the detailed summary of the RASC and Halifax Centre usage since March 26, 2020. With the details in the chart below, here is the quick summary:

- 7 members' meetings 3 held, 4 booked for the Fall in RASC account
- 5 sessions/tutorials held in Halifax Centre account
- 6 sessions booked for Nova East: The COVID-19 Edition! in Halifax Centre account
- 6 Board meetings held 2 in RASC account, 4 in Halifax Centre account; Fall meetings TBD
- 2 Nova East Planning Committee in Halifax Centre account; fall wrap-up meeting date TBD

To determine usage, meetings must have registered attendees; the reports provide only the number registered, not the number actually logged in. On the other hand, webinars provide 4 sets of data for those sessions that required registration: number registered, total users, unique viewers and maximum concurrent.

#### **Questions for the Board**

Given the COVID-19 situation and the impact it has on how we meet and deliver programs, how do we want to proceed with the Zoom Pro account:

- a- Continue using the account and pay the monthly fee of \$20 + HST/month/host?
- b- Pay the annual fee?

# **G10: Policies Regarding Permitted Commercial Activities at Halifax Centre Meetings and Events**

(Original approval: 2000)

(Draft Revision for Approval: June 18, 2020)

#### **Background:**

RASC Halifax Centre holds regular Board of Directors and Members' meetings, and from time to time hosts Centre-organized outreach events. There are occasions when our Centre is asked by another group, institution or commercial entity to provide volunteers for an event or meeting they are hosting.

A previous policy had been approved by RASC Halifax Centre in 1999-2000 when meetings had been held at the Maritime Museum of Natural History.

#### Rationale

The Halifax Centre, as a non-profit organization dedicated to the advancement of astronomy, encourages interaction between its members to discuss and exchange information on the various aspects of astronomy so that they may benefit intellectually and gain from their membership in the Centre. Because of its non-profit status, the Centre reserves the right to place certain limitations on the activities of its members and non-members at its meetings and events that may be construed as violating its non-profit status.

It is important to provide guidance regarding limitations to commercial activities accepted at RASC Halifax Centre meetings and related events, such as Nova East Star Party and Centre-organized outreach events.

#### Policies Related to Commercial Activities at Members' Meetings

Subject to the following limitations, sale of goods and merchandise is limited to those items sold by the Centre to raise money to meet its expenses and objectives. The following limitations are placed by the Centre on members' and non-members' activities at the Centre's Members' meetings.

<u>Sale by Members</u>: Items which individual members of the Centre have for sale or trade may be displayed and sold by requesting permission from the Centre's Board of Directors at least 2 weeks prior to the meeting at which said items are to be displayed. The requirement for such permission is waived for "swap" or "sale" events at meetings organized by the Centre.

<u>Sale by Commercial Entity</u>: Upon request, firms or companies may be issued a written invitation by the Board of Directors or their designate to mount displays of goods or services which they have for sale. Without such an invitation, no firm or company may display goods or services at meetings of the Centre.

<u>Invitation to Display</u>: An invitation to display at general monthly members' meetings may be granted to a firm or company a maximum of two (2) times in any calendar year by the President or their designate and shall stipulate the following restrictions:

- 1. No items may actually be sold at the meeting;
- 2. The display shall be restricted to the area and time period assigned by the Board of Directors or their designate;
- 3. A sign (provided by the Centre) shall be visibly displayed adjacent to the display stating that the Centre does not necessarily endorse the products or services displayed, and takes no responsibility for the performance of either the vendor or their product and/or services:
- 4. Any other stipulation(s) which the President or the Board of Directors may make.

The Board of Directors shall not issue an invitation to display for a period of one (1) year to any firm or company which has failed to comply in any respect with the above stipulations.

Policies Related to Commercial Activities at Public Observing Sessions and Nova East Where meetings or events are held on the premises of another institution, any limitations on commercial activity imposed by the hosting institution will be respected. Individuals may sell or trade personal items provided no laws, rules or regulations governing the hosting authority are violated.

It shall be the responsibility of the firm or company to determine from the hosting authority that no rules or regulations will be violated by the display or sale of goods or any other commercial activity.

Commercial displays may not be placed nor sales be made on sites assigned to the RASC Halifax Centre if they violate the hosting authority's rules and regulations for commercial activity.

Firms or companies wishing to carry on commercial activities in conjunction with Centre activities must provide written proof to the Board of Directors or their designate that they will be permitted to carry on business at the specific location and time assigned to the RASC Halifax Centre.

Once such proof is provided, and upon request to the Board of Directors, firms or companies may be issued a written invitation to display which shall be granted at the discretion of the Board of Directors. Without such an invitation, no firm or company may display or sell goods or services at any site assigned to the Centre.

The invitation to display for such events shall carry the following restrictions:

- 1. The display shall be restricted to the area and time period assigned by the Board of Directors or their designate;
- 2. A sign (provided by the Centre) shall be visibly displayed adjacent to the display stating that the Centre does not necessarily endorse the products or services displayed, and takes no responsibility for the performance of either the vendor or their product and/or services;
- 3. Any other stipulation(s) which the Board of Directors may make.

The RASC Halifax Centre hereby grants approval for -

#### **Dispute Resolution**

If there is a dispute on the interpretation or application of these guidelines, the Centre's Board of Directors shall be the final arbiters and their decision shall be final.
