1. Welcome & Introductions

Pat Kelly called the meeting to order at 7:03 pm and welcomed members.

The meeting agenda was reviewed. There had been several issues discussed by the Board by email since the last meeting: the number of SkyNews magazine copies that the Centre should be receiving for outreach purposes; the number of RASC calendars we wanted to pick up from the printer; the cost of shipping a calendar into the US. 3. Report from National Council Representative

Pat indicated that there was nothing to report. He hadn't taken notes from the last meeting and minutes hadn't been distributed yet.

4. Education and Public Outreach

Paul Heath wasn't in attendance to report about Outreach requests received. Peter indicated he had approached the Discovery Centre about a possible International Observe the Moon Night (InOMN) collaboration with them, but they had indicated they didn't have the staff to put toward something at this time. There was discussion of whether we might or should put something together on our own, and where we might do this. It was agreed we would wait until the next Board meeting on September 28, 2021 when we would have a better idea of what the COVID situation might be on October 16, 2021, and there would still be the Members' meeting on October 2, 2021 to call for volunteers, if we did choose to proceed.

5. RASC Halifax Centre Website

Judy Black wasn't in attendance and there was no update on the Centre website.

6. Financial Update

Gregg Dill wasn't in attendance and there was no financial update.

UPDATES/REPORTS

7. SCO

John Liddard wasn't present when we got to this agenda item. Pat suggested we come back to it when John was able to join the call. We returned to this agenda item after John had joined the meeting.

John reported that he had been out to SCO about a month ago to check on things and noticed that the GFI plug in the southwest corner of the roll off had failed. He had since purchased a replacement and intended to replace the failed GFI. If it fails again, that would indicate that there is an issue with the plug location and exposure to the elements rather that it just being a bad GFI, then we will have to replace the plug with a GFI breaker in the power panel. This would cost more but would be a more permanent solution.

John reported that the green felt-like material on the floor of the roll off is starting to lift off and makes cleaning the roll off floor very difficult. He proposed removing the floor covering. It was agreed that he should proceed.

John reminded us that the other remaining SCO issues were running power to the storage building/washroom and removing the propane heater and installing an electric heater in the warm room. The earlier estimate to run power to the storage building/bathroom had been \$700-\$800. We don't have a price to install the electric heater although we do have the heater purchased. And we don't know what the SCO budget balance. John agreed to get new cost estimates from the electrician and then to contact Gregg for an update on the SCO budget so we can decide whether to proceed at this time.

John also reported that he had given a SCO orientation to Bob Russell and given him a SCO key.

8. Member Survey Results

Pat indicated there was no update on the Member Survey. The survey distribution had been set up by Jenna Hinds at National office using their SurveyMonkey account and members were notified by Judy in an email distributed on June 4. 2021 and again at the Members' meeting on June 5, 2021. Fifteen responses were received. It was intended that Pat would send out a second reminder to Centre members via the Centre Announce List, but when he tried to update the mailing list from the new membership database, he was unsuccessful. He was still waiting to hear that the problem with the database had been fixed. Pat agreed to include mention of the situation at the Members' meeting on Saturday under News from the Board.

It was noted at this point that the Agenda item numbering jumped from 8 to 11. And that SCO Use Guidelines was on the Agenda as item 11 and 12. The agenda will be renumbered and then reflected in the minutes.

GOVERNANCE

9. SCO Use Guidelines

Pat indicated that steps taken since the last Board meeting on June 1, 2021 were summarized in Agenda Note #2. The current Guidelines were approved by the Board by email. There was nothing since, we are still in Phase 4 and the current Guidelines are still appropriate. Kathy indicated that she was waiting to see what was announced regarding Phase 5 and that she and David would draft and circulate appropriate changes by email when that happened.

NEW BUSINESS

10. SkyNews magazine and RASC Calendars

During preparation for Kejimkujik Dark-Sky Weekend, Paul Heath had indicated that he had been receiving 50 complementary copies of SkyNews magazine for Outreach purposes, but due to COVID-19 restrictions, there had been little opportunity to distribute them, and he was running out of space to store them. During DSW and afterward, there were discussions about how to resolve this and there was a suggestion that Paul only needed to keep copies of the most recent year. Peter had taken copies from 2020 to Keshen Goodman Public Library to be put on the free book table but copies from previous years were put out for recycling. There had also been discussion by email whether we should reduce the number of SkyNews copies that we received from the printer/National office to 20 per issue until COVID restrictions were relaxed and our Outreach activities increased again.

Also in the preceding week, there had been an email discussion by the Board of the number of RASC calendars we should pick up from the printer to sell directly from the Centre. Last year, we had picked up 50 copies and likely because there were no face-to-face meetings, there are still 15 unsold calendars. It had been agreed by email that this year we would only pick up 30 copies from the printer. This was for information only; no further action or motion is required.

There had been a question around this of the price of ordering a copy of the 2022 RASC calendar from the Centre to be mailed to the USA compared to purchasing a copy from the National office. Pat tried to sign onto the National website to determine the cost but was unable to get the information. Peter agreed to contact National office directly.
